### All Memberships have these great benefits.

1) No matter which membership you choose you will be extended the same greens fee privileges at both **West Bend Lakes** and **The Golf Club at Camelot** 

Example Weekday vs Full

If you walk at the other courses the fee will be \$0—if you ride, you will only pay the cart fee. Cart memberships are not transferrable to other courses.

2) If you pay before:

Dec 31st 2023 you will receive a 10% rebate on the member rate

Jan 1st to Feb 14th you will receive a 3% rebate

(Rebates are on the pre tax rate & includes all memberships ie. green fees, carts etc.)

PLEASE NOTE: This is a rebate program—the rebate will be placed into a charge account for your use—This is NOT a discount to your membership payment.

- 3) All members will be able to make tee times 10 days in advance—the public will have 7 days.
- 4) We will once again have reciprocal rates with other courses not owned by us.
- 5) Accounts will be available to you for charging Food, Beverage, Range, Golf or Merchandise.
- 6) All members will receive 10% discount on all pro shop purchases
- 7) 10% Referral Rebate When you (existing 2023 member) refer a New Member (New Member must specify who they were referred by at the time of payment, and New Member must not have been a previous 2022 member)
- 8) Instant 5.5% Loyalty Discount As a 2023 Member, we thank you for returning and will pay the 5.5% sales tax on your membership fees for your 2024 membership. All you need to pay is the Pre-Tax amount.

#### **Full Members**

Full Members have free golf 7 days a week including holidays. We recommend that members make tee times to ensure availability.

### **Week Day Members**

Weekday members have free golf 5 days a week (Mondays thru Fridays including all weekday Holidays). We recommend that Members make tee times to ensure availability.

#### **Cart Members**

Those who rent our carts ride for free. Any guests of cart members are required to pay for cart usage.

### **Cart Owners**

Those that own their own cart can have a rider for free. However, they must be in the cart with the owner of the cart.
